



Guidelines for English-language Manuscripts

To submit a manuscript for publication in the journal *Archaeologia Austriaca*, we kindly ask you to contact us by e-mail (archa@oeaw.ac.at) in order to receive your personal access data. Please then log in at <https://orea.vlg.oeaw.ac.at/index.php/archaeologiaaustriaca/login> and upload your contribution with all associated files.

Archaeologia Austriaca publishes articles, short reports, special sections and book reviews. Contributions published in the ‘Article’ section must formulate clearly defined research questions and objectives and describe the appropriate methods. The presentation of the research results is followed by an interpretation and discussion of the results with appropriate contextualisation, including the relevant research literature. Papers should include an abstract in English and German (max. 150 words each) and up to 7 keywords (English and German). English is the preferred language of publication, contributions in German are also welcome.

Short Reports are scientific to the point contributions that provide the opportunity to briefly present research projects and results, discuss current topics or introduce new methods. Short Reports comprise up to 1500 words (including title, abstract, acknowledgements, references) and may contain a max. of 6 figures and tables. A short concise title, an abstract of max. 65 words and up to 5 keywords complete the report. The publication language is English.

Both articles and short reports are subject to international peer review and are published in print and online (open access).

By submitting a manuscript to *Archaeologia Austriaca* through the online system, authors declare that the manuscript is complete and that the exploitation rights to the work have not been exercised elsewhere either fully or partially. Authors have to possess the copyright and/or right to use all parts of the work; this especially applies to images in the work. Authors are themselves responsible for obtaining the permission for publication and reproductions from copyright holders for all illustrations.

If the contribution is not submitted in the author’s first language, the author is expected to ensure that a native speaker has checked the text for correct English. The journal attaches great importance to gender-sensitive and respectful language, which should be used consistently throughout the article. *Archaeologia Austriaca* does not publish articles that have previously been published (in any language) or are concurrently submitted for publication elsewhere.

Authors must properly cite publications and acknowledge non-authors who have helped in the development of the work. Authorship should be limited to those who have made a significant contribution to the work. These persons must be listed as co-authors, and the extent and nature of their contribution must be specified.

AI tools cannot assume authorship. The use of AI tools in the creation of content must be made transparent, with the exception of translation tools or spell-checking programs that do not generate content independently. Authors are fully responsible for the content of their submitted work, and therefore also for parts that may have been created using AI tools. The main or the corresponding author is responsible that all co-authors have agreed to submission of the final version.

- **Text files** must be submitted as digital documents (ideally as ‘word.doc/docx’). Please submit a ‘word.doc/docx’ file and apply as little formatting as possible. Do not CAPITALIZE and do not underline words (for highlighting words use ‘inverted commas’), no indentations, no word-division etc.
- **Tables** should be submitted as separate ‘word.doc/docx’ files and should be labelled as follows: <ArchA_author_Tab_01>, <ArchA_author_Tab_02>, etc.
- **Figures and plates** have to be submitted as separated files (allowed formats .tif, .ai, .pdf, .psd, .eps). The files should be labelled as follows: <ArchA_author_Fig_01>, <ArchA_author_Fig_02>, etc.; <ArchA_author_Plate_01>, <ArchA_author_Plate_02>, etc.



Save black and white images in greyscale mode and colour images in CMYK (not RGB). The resolution for line drawings should be between 800dpi and 1200dpi, for photos between 300dpi and 450dpi. Vector graphics should preferably be submitted in the original format (e.g. .ai, .eps); linked images and fonts must be embedded.

Maximum figure and plate size: 170 mm × 236 mm (incl. caption). Set the precise measurement at which you wish the figures and plates to be printed: Width 81 mm, 111 mm or 170 mm (other widths are only possible in exceptional cases); height up to 236 mm. In the case of multi-line captions – one line covers approx. 20 words – the figure height needs to be shortened by 3 mm per line; e.g. caption with three lines, max. image height 230 mm.

Indicate the most appropriate place where the figures shall be inserted into the text, e.g. by writing **<INSERT FIG. 1 HERE>** at the end of a paragraph and in a separate line.

- The **main text file** should contain the following information (in the following order):
 - Title of contribution
 - Author(s) first and surname(s)
 - Abstract
 - Keywords
 - Main text (including subheadings and cite references in the text by name and year in parentheses)
 - If applicable: Acknowledgements (following the main text)
 - References
 - Name, affiliation, address, e-mail and [ORCID-ID](#) of all authors
 - List of table, figure and plate captions (including credits)
